POLICY OF INTERACTIONS WITH GOVERNMENT



Introduction: This Policy applies to all directors and collaborators of Farmacéuticos Maypo and establishes the principles with which interactions with government officials should be carried out, from their intent, definition of purpose, to documentation of the results and actions resulting from the interaction. Our goal is to ensure that all negotiations and operations of Farmacéuticos Maypo with government officials are conducted in compliance with all national and international laws and regulations, and in accordance with the highest standards of integrity required in conducting business, as stated in our Code of Conduct.

Learn more about the Policy: For the purposes of this policy, it is important to differentiate the public servant who is classified in this way, solely because he/she works in a public institution and receives his/her salary from government or public funds (Public Servant), from the one who additionally holds the capacity to make decisions that may directly impact any business of Farmacéuticos Maypo (Government Official).

These are characteristics of the Government Officials, hereinafter referred to as “GO”:

- 1 Decision-making capacity that may directly affect the purchase, approval, or use of products, services, or prescription of drugs marketed by Farmacéuticos Maypo.
- 2 Ability to conduct inspections, regulatory opinions or impose sanctions.
- 3 Ability to grant/authorize/revoke permissions, registrations, or licenses.

These are characteristics of public servers:

- 1 Be employees of a government-owned or funded hospital, clinic, university, or other entity, and/or.
- 2 They receive funds, fees, or other compensation from a government-owned or funded hospital, clinic, university, or other entity

Note: Doctors and other health care professionals can be considered public servants if:

- They are employees of a government-owned or funded hospital, clinic, university, or other entity, and/or.
- They receive funds, fees, or other compensation from a government-owned or funded hospital, clinic, university, or other entity.

Interactions with GO

But not limited to, however, the following activities are considered to be interactions with a GO:

- 1 **Hiring of a GO for the provision of professional services** permitted by law, including consultations, conferences, trainings, among others. In all cases, it should be ensured that there is no potential conflict of interest between Farmacéuticos Maypo and the GO.
- 2 **Interactions with a GO during a meal.**
 - a Guidelines and amounts authorized for meals, maximum number of attendees by the company.
 - b Payment to GO companions is not allowed.
 - c Where applicable, document the authorization and reporting of conclusions resulting from the interaction with a GO during a meal.

Grants

- 1 In order to award a grant, it is essential that it be requested in writing, analyzed, and authorized by the relevant committee and documented in a contract.
- 2 The grant must be for the purposes of education, dissemination of science or medical knowledge or public health interest.
- 3 When Farmacéuticos Maypo awards any donation or grant it does not intend to receive a benefit or compensation in return.
- 4 Farmacéuticos Maypo does not award donations or grants proactively.
